- 1. The Academic score as specified in **Appendix II** (**Table 3B**) **for Colleges** shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.
- 2. A relaxation of 5 % may be provided only for the reserved posts at the Graduate and Masters level for the Scheduled Caste/Scheduled Tribes/Differently-abled(Physically and Visually differently-abled/Other Backward Classes (OBC)(Non-creamy layer) categories for the purpose of eligibility and for assessing good academic record during direct recruitment to faculty positions.
