# **Delhi Police denies** Ashneer Grover, wife nod to travel to UK

THE DELHI Police has rejected a representation from Ashneer Grover, the former managing director of BharatPe, and his wife,

Madhuri Jain Grover, requesting permission to travel to the UK later this month as guest speakers at the London School of Economics (LSE). Sources said Ashneer and Madhuri had submitted a representation to the investigation of-

ficer of the Delhi Police's Economic Offences Wing(EOW) in the last week of February, seeking travel permission for the UK from March 9 to March 15 as guest speakers at the LSE and the University of Warwick, among others. "After reviewing their representation, the investigation officer denied the permission," a source said. When contacted, Grover told

and keep winning in Court. I've not got any correspondence regarding the travel permission (which is a confidential correspondence) as yet from EOW."

On November 16, 2023, Ashneer and Madhuri, scheduled to travel to the US, were stopped at the Indira Gandhi International Airport - Terminal 3 and informed that a Look-out Circular (LOC) had been issued against them, effective November 6.

The couple then approached the Delhi High Court, seeking to quash the LOC. On February 1, Justice Subramonium Prasad, before whom the matter came up for hearing, listed it for May

8, stating that the investigation in the case registered by the

EOW is at a nascent stage. "It is too hot in the day for this court to intervene now, Come after some time. The investigation is at a nascent stage and they will take some time to investigate," the high court said.

Justice Prasad, however, said that the petitioners' application to travel abroad for two days may be considered by the authorities concerned based on the facts of the case.

The EOW had registered an FIR in May last year against the Grovers and other family members for alleged misappropriation of funds and causing losses worth Rs 81 crore to Resilient Innovations Private Limited, which runs the UPI platform

The EOW FIR was registered under various provisions of the Indian Penal Code (IPC), including sections 406 (criminal breach of trust), 420 (cheating and dishonestly inducing delivery of property), 468 (forgery for the purpose of cheating), 471 (using as genuine a forged document), and 120-B (criminal

## Walked 1,600 kms, told you about woes, says L-G as Delhi govt alleges 'dirty politics'

THE WAR of words between the Delhi government and Lieutenant Governor VK Saxena over poor conditions in unauthorised colonies and slums continued the second day in a row, after the latter posted photos of his visit to Qalandar Colony in Shahdara, asking the CM to take action.

On Tuesday, when the L-Gvisited Sangam Vihar, posting photos from his visit and accusing the AAP government of not improving the living conditions in these areas despite being in power for nine years, Kejriwal had said that Saxena was playing the role of the opposition despite holding a constitutional position. Kejriwal also directed the Chief Secretary to take action in the matter immediately and sought a daily report.

On Wednesday, after his Shahdara visit, Saxena tagged Kejriwal in a post on X (formerly Twitter), and said it was his constitutional responsibility to highlight the issues of the people before the Chief Minister, "From the first day of taking charge till today, I walked more than 1,600 kms in different areas of Delhi in 650 days and...always kept you informed about the problems... Local people said that 35-40 thousand people live a pitiable life in about

4,000 houses here. It is the responsibility of DUSIB to provide basic ...facilities in this slum, of which you yourself are the Chairman, and cleanliness is under the MCD... Hope you will show positivity on this issue," he wrote.

The Delhi government, in response, accused Saxena of "playing dirty politics".

"Yesterday, when he raised certain issues...the CM, in good faith directed the CS to solve the problems within a week CM also urged L-G to take strictest action against delinquent officers because their vigilance and disciplinary matters are within the jurisdiction of L-G. It has been more than 24 hours. L-G has not taken any action...Why? It means L-G is himself encouraging and forcing officers not to do their work so that he can then create drama by visiting these areas and blaming Kejriwal.... In any case, the CM has directed CS to address all the new issues raised by L-G today," the government's official statement

## Excise policy case: ED moves court again after Kejriwal skips 8th summon

New Delhi: Enforcement Directorate (ED) has, for the second time, moved Delhi's Rouse Avenue Court filing a complaint against Delhi Chief Minister Arvind Kejriwal for allegedly not complying with the summonses issued by the agency in the liquor

Kejriwal appeared before the court on the said date via videoconferencing saying that he could not appear physically due to the confidence motion and Budget session in the Assembly.

## 'AAP govt presented twisted facts, L-G office maligned': Plea in HC

THE OFFICE of Lieutenant Governor VKSaxena has moved a plea before the Delhi High Court, seeking to intervene in a matter concerning conforming and nonconforming wards for liquor vends in the national capital. It said the AAP-led government in Delhi has presented \*twisted and distorted facts" in the matter, and "maligned" the L-G office.

In its application for intervention, the L-Goffice submitted that the committee report constituted by Saxena in April 2022, to carry out a detailed survey in identifying such wards, finally reached him on January 16 this year.

The plea submits that while the report was not pending consideration before the L-Goffice, all along it "appears that a false statement was caused to be made to the effect that the Lt Governor was not taking any action on the report, and that he was delaying the matter", pointing to different orders in the matter.

It further states that even now, the correct picture has not been presented, adding that after the report was placed on January 16, the L-G - conscious of the next hearing - had given his approval on the report on February 3 and forwarded it to the CM with an "explicit noting" that it be filed before the next hearing. Instead of complying with the L-G's directions, the plea submits that the

Delhi government filed an application seeking time extension to place the report on record.

"The facts above reflect a distressing plight, where the GNCT of Delhi refuses to take responsibility of its own lapses and omissions. What is even more concerning is the manner in which the responsibility is falsely attributed to a constitutional authority with no regard for accountability of one's actions. It is respectfully stated that this is not only an affront to a constitutional post and the person, who is an eonominee of the President of India, but also unduly erodes the credibility of the person holding such a post, and his body of work. The manner in which the twisted and distorted facts were presented before the Hon'ble Court in this matter is a deliberate attempt to mislead the Hon'ble Court and maligning the constitutional office of the Lt. Governor..." the plea submits.

The plea further submits that as per the L-Goffice's understanding, the report of the committee was submitted on August 18, 2022, and moved by the Excise department the same day for seeking the I-G's approval. "However, thereafter the applicant understands that the committee's report... was being kept pending approval before various departments of the GNCT of Delhi, and finally reached the Applicant only on 16.01.2024, after about 16 months," the plea states.

The matter is next listed on March 20.
