### **CONTINUATION ORDER**

WHEREAS, the recognition under section 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Vasanta College for Women, Rajghat Fort, Varanasi-221001, Uttar Pradesh for conducting B.Ed. course of one year duration with an annual intake of 70 ( Seventy only) from the academic session 2000-2001 vide Order No. F.NRC/NCTE/F-3/UP-144/B.Ed./2000/16036-43 dated 19.09.2000.

AND WHEREAS, the institution has submitted representation through Email dated 09.01.2023 and letter dated 17.01.2023 requesting to issue revised recognition order for two year duration for B.Ed. Progrmme. The matter was placed before NRC in its 391th meeting (Virtual Mode) held on 02th February, 2023 and decided as under:

"The original file of the Institution along with other related documents, reply of the institution dated 11/08/2021, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by the NRC and the committee observed the following :-

- The recognition was granted to the institution for B.Ed. course of one year duration for an annual intake of 70 seats vide order No.F.No. F-3/up-144/B.Ed./2000/6036-43 dated 19.09.2000.
- The institution has submitted the FDRs Rs.7 lakhs and Rs. 5 lakhs towards Reserve fund and Endowment Fund.
- The institution is multidisciplinary in nature.
- The institution has submitted PAR for the Academic session 2020-2021.

In view of the above, the NRC has decided to allow Vasanta College for Women, Rajghat Fort, Varanasi-221001, Uttar Pradesh to continue the recognition for B.Ed. course for two year duration with an intake of one unit (50 students).

- NOW THEREFORE, this order is issued permitting the institution i.e. Vasanta College for Women, Rajghat Fort, Varanasi-221001, Uttar Pradesh for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of one unit (50 students) subject to fulfilment of the following conditions:-
- The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint (i) account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

(ii) The institution shall comply with the various other norms and standards prescribed in

the NCTE Regulations, 2014 as amended from time to time.

- (iii) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- The institution shall ensure that the required number of academic staff duly approved (iv) by affiliating body for conducting the course should always remain in position.
