The agreement made and entered into on the ...18th.. day ofOctober..., 2022 between "DEPARTMENT OF ENGLISH, VASANTA COLLEGE FOR WOMEN, RAJGHAT" (hereinafter referred as VCW) situated at Varanasi, Uttar Pradesh, India and "NEBRASKA WESLEYAN UNIVERSITY" (hereinafter referred as NWU), situated at Lincoln, Nebraska, USA.

1. PURPOSE OF THE MOU

The main purpose of this MOU is to develop academic and educational collaboration and to promote mutual understanding between VASANTA COLLEGE FOR WOMEN, RAJGHAT, VARANASI, UTTAR PRADESH, INDIA and NEBRASKA WESLEYAN UNIVERSITY, LINCOLN, NEBRASKA, USA, situated at Lincoln, Nebraska, USA in mutually beneficial areas.

2. PROPOSED MODE OF COLLABORATION

VASANTA COLLEGE FOR WOMEN, RAJGHAT, VARANASI and NEBRASKA WESLEYAN UNIVERSITY, LINCOLN, NEBRASKA proposes to collaborate through:

- a. Online mode will be followed during the period of collaboration.
- b. Promoting mutual faculty exchange for academic growth in specific courses and papers as mutually agreed. The syllabi will be shared by both the Parties.
- c. One-time guest presentations in one another's classes as per semester.
- d. Exchange (Virtual) of students for peer-tutoring and participation in academic activities like Seminars, Conferences, Workshops and Training programmes.
- e. Co-design and teach a transnational course online in which time zone and semester scheduling will be fixed as per the convenience of both the Parties.
- f. There will be no financial implication from either side.
Certificate of Appreciation will be issued for each of the efforts made on both the sides for above mentioned academic and exchanges programmes.

3. EFFECTIVE DATES AND AMENDMENTS


- a) This MOU shall take effect upon signing by both Parties and shall remain in effect for a period of Three (3) years from the date of signing the agreement unless terminated. Neither party may assign or transfer all or any portion of this MOU without the prior written consent of the other party.
- b) The MOU may be renewed at the end of this period by mutual written agreement by both Parties.
- c) The provisions of this MOU may only be amended or waived by mutual agreement by both Parties.
- d) Any Party may terminate this MOU and any related agreement for any reason by giving thirty (30) days prior written notice to the other Party.

4. RELATIONSHIP

Nothing in this MOU shall be constructed to make Party, a partner, an agent or legal representative of the other for any purpose.


