MEMORANDUM OF UNDERSTANDING

Partnership Programmes between

Vasanta College for Women

and

DAVPG College

This memorandum of Understanding (MoU) is being made between the Vasanta College for Women, Rajghat Fort, Varanasi, hereinafter referred to as 'VCW'

and

DAVPG College, Varanasi hereinafter referred to as 'DAVPG'

In order to promote cooperation and the advancement of academic, research, and educational exchanges between VCW and DAVPG the two institutions agree to formalize an MoU which is as follows:

Within fields that are manually acceptable, the following general forms of cooperation will be pursued:

1. Use of facilities for Academic & Research

VCW would allow Research scholars and Post Graduate students from DAVPG, the use of its library, cyber library and other facilities for academic & research purposes. DAVPG in turn would in the selfsame manner allow scholars from VCW to avail of its facilities for academic & research purposes.

2. Academic visits/Exchange of faculty

The two institutions will collaborate in planning and delivery of academic programs and course and will also partner with each other in organization of seminars, workshops and conferences including the exchange of mutual experiences in teaching and research.

3. Joint teaching program, research activities and publications

The two institutions will collaborate in developing teaching programmes in interdisciplinary areas of specialization of high relevance to both the institutions at the post graduate and doctorate levels. The two institutions will also take up joint research projects.

4. Participation in seminars and academic meetings

The two institutions will promote participation in Seminars/Workshops etc.

The Memorandum of Understanding (MoU) shall remain in force for a period of **five years** from the date it is signed by the appropriate officials of the two institutions. It may be extended further or amended with the written agreement of both the parties. This MoU may be terminated by either party subject to the delivery of one year advance notice, in writing.
